# SOUTH AYRSHIRE COUNCIL'S GRANTS SCHEME TO SUPPORT VOLUNTARY ORGANISATIONS

South Ayrshire Council recently undertook a review of the existing grants system providing financial support to voluntary organisations. This included the grants that were operated via the Council's General Purpose/Rural Panels and the Community Development Fund.

The findings of the review confirmed the Council's commitment to continue to support the voluntary sector via grant funding. However the existing grants scheme ceased on 31st March 2016 and will be replaced by a new approach. The final arrangements are being completed presently which will include the use of updated forms and processes.

Supporting Rural and Coastal Communities throughout Ayrshire

### **AYRSHIRE LEADER PROGRAMME 2015-2020**

This scheme provides financial assistance for farmers, foresters, rural businesses, public sector bodies, social enterprises and community organisations based in rural Ayrshire LEADER area. The programme is provided by the Scottish Government and is delivered on their behalf by the Ayrshire LEADER Local Action Group (LAG).

### The vision for the LAG is:

"To provide the investment to inspire, build confidence and strengthen local communities and business, generating new opportunities to support resilience and wellbeing across Ayrshire".

### Our goals

- Ayrshire realises its full economic potential with more and better employment opportunities for its people
- Ayrshire people live in well-designed, sustainable places where they are able to access the amenities and services they need
- Ayrshire has strong, resilient and supportive communities where people take responsibility for their own actions
- Be responsive to new challenges and opportunities helping communities and enterprise to adapt and develop over time
- Through partnership working we will create the conditions to succeed

### Our core values:

Our core values acknowledge the seven principles of the LEADER approach to ensure the LAG:

- ✓ Put our communities at the heart of developing and delivering our strategy
- ✓ Are fully accountable for our decisions
- ✓ Maintain transparent and robust governance
- ✓ Are professional and approachable
- ✓ Communicate in a clear, concise, and inclusive manner

### **DECISION MAKING FOR APPROVAL OF FUNDING**

There is a delegated decision making process for LEADER investment requests of between the £1,000 minimum threshold and £99,999. High-value requests of £100,000 or more will be considered by the full LAG.

### £1,000-£2,999 (LEADER request)

Applications of this value will be technically assessed by the Programme Coordinator and a written recommendation will be provided to three LAG members for consideration.

These applications, whilst considered small-value investments must demonstrate a contribution to the Local Development Strategy.

### £3,000-£99,999 (LEADER request)

Applications within these values will be technically assessed by the Programme Coordinator, and a written recommendation will be provided to the relevant Thematic Action Group for consideration and decision.

These small to mid-value thematic applications will be expected to demonstrate a contribution to the Local Development Strategy equitable to level of grant request.

### £100,000 + (LEADER request)

Large scale and strategic project seeking £100,000+ of LEADER investment will be technically assessed by the Programme Coordinator and a written recommendation will be provided to a full LAG meeting for consideration and decision.

These projects will be considered high-value investment initiatives that will be expected to make a **key contribution** to the Local Development Strategy. In addition, the LAG may identify specialist advisers to assist with any technical, financial, marketing, management aspect of the application, where they deem it necessary.

Drawing together the development needs and opportunities of rural and coastal Ayrshire with the strategic overview of EU and Scottish context, lead to the development of five themes that have been created, reviewed and refined in consultation with people who live and work in Ayrshire.

The following themes, objectives and priorities will guide funding decisions made under the 2014-2020 Programme.

### **FOSTERING BUSINESS & ENTERPRISE**

### Objective:

By 2020, rural Ayrshire realises its full economic potential with more and better employment opportunities for its people provided through creating or enhancing small rural enterprises, creating new jobs and increasing the skills base.

Support will be directed to small and micro businesses, including those in tourism etc. to improve their competitiveness and/or facilitate diversification from primary production.

Initiatives supported under this theme will need to demonstrate how they meet the following priorities:

- Creating and/or supporting small and micro enterprises
- Creating and/or safeguarding jobs
- Building business capacity and skills, e.g. through support networks or forums, business incubators and mentoring
- Facilitating and supporting farm diversification
- Identifying and developing new markets for new and existing products or services
- Support new bespoke initiatives to provide skills which will help deliver enhancements to existing businesses and assist in the start-up of new companies
- Foster entrepreneurship through small scale pilot initiatives to trial new rural business ideas

### **CONNECTING PEOPLE & PLACES**

### Objective:

By 2020, people living and working in rural Ayrshire are better connected physically, digitally and socially and are able to access the amenities and services they need.

Initiatives supported under this theme will need to demonstrate how they meet the following priorities:

- Creating affordable transport solutions that link key demographic groups (e.g. young people, older people) with the amenities and services they need (e.g. employment, training and health and social care services)
- Support and mentoring to increase digital inclusion
- Intergenerational activities to facilitate digital, social, or physical connections
- Supporting community facilities (e.g. centres) to become well used, high profile and multi-purpose, connected community hubs

### **PROMOTING TOURISM, CULTURE & HERITAGE**

### Objective:

By 2020 rural Ayrshire's people better capitalise on the area's cultural, historical, recreational and natural assets to improve the visitor experience, visitor numbers & spend, and local skills & employment in tourism.

Initiatives supported under this theme will need to demonstrate how they meet the following priorities:

- Creating connections between sectors (e.g. food & drink and local crafts) through knowledge exchange, networking, and collaboration
- Promoting, showcasing, and marketing Ayrshire's assets
- Supporting skills development in tourism-related activities
- Improving the visitor experience and visitor infrastructure

### **CELEBRATE OUR NATURAL ENVIRONMENT**

### Objective:

By 2020, rural Ayrshire's people have increased awareness, knowledge and enthusiasm to reap the social, economic and environmental benefits of the area's abundant natural assets.

Initiatives supported under this theme will need to demonstrate how they meet the following priorities:

- Increasing awareness of and interest in the area's biodiversity
- Enhancing and protecting the area's natural heritage
- Reducing the local carbon footprint through actions on climate change
- Improving access to the natural environment

# SUPPORTING COASTAL COMMUNITIES (FISHERIES LOCAL ACTION GROUP FLAG)

### Objective:

By 2020, key rural coastal communities in Ayrshire are sustainable through diversifying their local economies with an increase in employment and skills of people living in these areas, while protecting the marine environment.

Initiatives supported under this theme will need to demonstrate how they meet the following priorities:

- Supporting lifelong learning and job creation in fisheries areas, maintaining the skills of fishermen as fishermen and re-skilling them to be able to offer new services (e.g. to tourism or renewables)
- Supporting coastal communities to diversity their local economies through, for example, improving the tourism offer (e.g. through providing easy access to the water for recreation) and supporting the use of local food in Ayrshire restaurants and markets
- Creating links between and adding value to existing marine initiatives (e.g. Marine Spatial Planning, the work of Clyde 2020) and between marine and freshwater environments

• Strengthening the role of fisheries communities in local development and the governance of local fisheries resources

There are three funding strands available through the Ayrshire LEADER Programme:

### 1. Main Fund:

Funding of between £1,000 and £200,000 is available, and up to 50% of eligible costs will usually be funded. Open to community, voluntary and third sector organisations, charitable, and public bodies.

### 2. Farm Diversification and Rural Enterprise:

Funding of between £1,000 and £45,000 is available, and up to 50% of eligible costs will usually be funded. The farm diversification scheme is open to farmers looking to diversify into non-farming activity and the small rural enterprise scheme is open to those setting up or expanding a rural business.

### 3. Co-operation Fund:

Applicants for the co-operation fund should discuss their project idea with the LEADER team directly before submitting an Expression of Interest. This is open to applicants working across different LEADER areas, either in Scotland, the UK, or in Europe.

The Ayrshire LAG will cover rural areas in South Ayrshire, East Ayrshire and North Ayrshire, with eligible areas including all rural South Ayrshire settlements including Mossblown, Annbank, Tarbolton, Coylton, Maybole, Maidens, Kirkmichael, Dailly, Dundonald, Girvan, Ballantrae, Pinwherry, Barr, Barrhill.

### WILL CHARITABLE TRUST OPEN TO APPLICATIONS (UK)

The Will Charitable Trust provides support within the following categories: care of and services for blind people; long-term care of people with learning disabilities; and care of and services for people suffering from cancer.

Grants are currently available for the care of and services for people suffering from cancer, and their families.

UK registered or exempt charities are eligible to apply. Applicants must be based mainly within the UK, although some work abroad may be permitted. Applicant organisations must have proven track records of successful work in their field of operation or, in the case of newer charities, convincing evidence of ability.

Grants vary in amount, but generally fall within the range of £5,000 to £20,000.

The deadline for applications is 31 August 2016.

### MONEY ADVICE SERVICE - WHAT WORKS FUND

This scheme has been launched across the UK to help organisations pilot new approaches for improving financial capability and to evaluate their projects. It has been set up to provide financial support for projects which are focused on building evidence of the types of interventions that can make a measurable difference to people's financial capability.

The Programme consists of two parts:

- Stream A will fund and evaluate projects seeking to help answer the 'What Works questions'
- Stream B will fund pilot activity focused on capacity building and sharing of best practice among financial capability practitioners

Up to £7 million is being made available for 2016/17. Of this £600,000 is committed to Stream B, which will open for applications in July 2016. Further information will be published as it becomes available. However as a general guide, the following grants are expected to be available for Stream A, which is currently open for applications:

- Grants to evaluate an existing intervention are estimated to be between 10–20% of the intervention's delivery costs, although this is strictly a guide figure and the cost may be more or less.
- Grants to expand the scope of an existing intervention to reach a new audience and evaluate its impact could be between £50,000 and £1 million depending on scope and target group.
- Grants that would develop and test new pilot interventions for a specific audience could be up to £250,000.
- Effective, learning-focused evaluation is central to this grant programme. As such MAS does not expect to award grants under £5,000.

Applications for Stream A will be considered from any organisation in the UK that delivers financial capability interventions, or which may wish to do so in the future. This includes charities and other third sector bodies including trusts; commercial organisations (but not for projects that result in any commercial advantage or profit); social enterprises; local authorities; housing associations; and education bodies.

Applicants are encouraged to put in joint bids in partnership with other providers or other organisations.

Funding for Stream A is intended to support three types of projects:

- Existing interventions
- Expanding existing interventions
- Piloting new approaches

Projects should help answer the questions 'what works' either fully or with a more specific focus on:

- Children and young people
- Young adults
- Working-age people
- · Retirement planning
- Older people in retirement
- Financial difficulties

Projects must be delivered by the end of February 2018, although the preference is for projects that can deliver robust evidence of their impact within the 2016/17 financial year.

The Money Advice Service (MAS) is using the Bravo Sourcing portal for this Expression of Interest application exercise.

Applicants will need to register on the Bravo Sourcing portal to access the application forms and submit an application.

The deadline for Expression of Interest for Stream A funding is 12 noon on Friday 8 July 2016.

# VISITSCOTLAND GROWTH FUND IS CURRENTLY OPEN TO APPLICATIONS

The VisitScotland Growth Fund provides funding for well-researched, collaborative marketing projects. Applications are encouraged from groups of tourism businesses in Scotland operating at a local, regional or national level that will assist the tourism industry to meet targets regarding the national Tourism 2020 strategy. Applicant groups should consist of at least three tourism businesses.

Applications will be assessed on criteria such as achievable, measurable growth targets and project viability and deliverability. When creating their proposal, applicants should bear in mind the core objectives of the fund which are as follows:

- · Increasing the amount of people visiting Scotland
- · Increasing the overall visitor spend
- Encouraging visitors to travel more widely throughout Scotland
- Encouraging tourism throughout the whole year
- Developing and supporting the Scottish brand within the key consumer markets

Applications must include activity which is considered "new", i.e. working with new partners, targeting new markets, including new packages/offers, or using new media. Subsequent applications may be made, however the funding should not be treated as long-term or core funding. The Fund can support groups with 50% of approved total marketing costs over a one-year period, with a minimum award of £5,000 and a maximum of £40,000 available.

Applicants must ensure that they converse with a member of the Growth Fund team before beginning the application process, well in advance of the deadline. Applicants should either contact the team directly by email or else should complete an expression of interest form online.

The next deadline for this scheme will be 18 July 2016.

### **BID SEEDCORN GRANT IS CURRENTLY OPEN TO APPLICATIONS**

The Scottish Government provides seedcorn funding for the development of proposals for Business Improvement Districts (BIDs) in Scotland on a biannual basis. One-off grants worth up to £20,000 are available for local partnerships that involve the private sector, local authorities and other bodies. The grant take the form

of a single one-off payment and no further financial support will be provided by the Scottish Government.

This funding is designed to give local businesses a unified voice, and will help to provide businesses and local authorities with the opportunity to increase their understanding of each other's priorities. It is anticipated that this scheme will improve the quality of life of their citizens and will help to build strong local communities.

Funding should be used for appropriate activities such as marketing, website development and communications as well as covering expenditure such as relevant personnel costs. Other matters which enabled the development of a BID partnership or the development of an existing partnership will also be considered eligible for funding.

Grant applications must include a letter of support from local businesses as well as evidence that the local authority has been consulted and will support the project over an extended period of time, which may be up to two years in length.

The next award window for 2016 is between 1-30 June, with funding commencing 1 August.

# COMMUNITY FOOD AND HEALTH (SCOTLAND) – CAPACITY BUILDING FUND OPEN FOR APPLICATIONS

Community Health and Food (Scotland)'s Capacity Building Fund provides funding to support groups and agencies running food and health activities in Scotland to build the knowledge, skills and expertise they need to help them deliver their activities better.

Grants of up to £500 are available to community groups, voluntary organisations or social enterprises working with people in a low-income community or already involved in running a food and health activity.

The funding can be used for the following:

- All or part of the cost of a member of staff, volunteer, or management committee/board member taking part in a capacity building activity (for example a training or learning opportunity)
- All or part of the cost of delivering an in-house capacity building activity for staff, volunteers or management committee/board members

Applicants must be able to show how funding will build the knowledge, skills and expertise of volunteers, staff or management committee or board members, and demonstrate how this will make a positive difference to their food and health activities.

Applications can be made at any time until the funding is allocated.

# NEW COMIC RELIEF GRANTS STRATEGY AND NEW FUNDING PROGRAMMES

### 1. Girls in Gangs initiative

This scheme is open to applications from across the UK. Research and evidence shows that gang-involved girls and young women navigate a range of harmful environments which can expose them to high levels of sexual exploitation and increased criminal activity. We recognise that this is a complex issue.

Evidence shows the need to work much more systemically and calls for multi-partner, collaborative approaches to support young women and girls effectively in reducing their likelihood of joining gangs, reducing the harm they face within gangs and supporting them to leave gangs. Proposals are welcome **for up to £150,000 for 18 months of activity**, with the potential for a further £150,000 for a subsequent 18 month period.

The deadline for applications is midday on Wednesday 13 July 2016 (midday).

### **BT - COMMUNITY WEB KIT**

This scheme is open to small charitable voluntary and community groups in the UK that provide a clear benefit to the local community. A simple-to-build website may be constructed from simple onscreen instructions on the Internet.

As part of the BT Community web kit applicants will receive the following:

- Free website hosting
- Free website addresses
- The choice of eight templates with five or 15 colour themes depending on the template selected
- One free format template
- Enough space for unlimited pages and up to 500 pictures
- Templates and colour options for all content
- An easy-to-use page editor or an HTML editor for technically minded applicants
- Free technical support

To qualify, organisations must be based in the United Kingdom and provide a clear benefit to the local community. They should be registered charities, non-profit-making groups or volunteer-led organisations. Users are advised to contact the sponsor for details of any specific criteria that may apply.

Applications may be made at any time.

### **OPEN4COMMUNITY (O4C) DATABASE**

Search for funding using the O4C Database which is funded by South Ayrshire Council. It provides a valuable resource for individuals and organisations, in both the private and public sector, looking for funding.

Registration on the system is free, quick and easy. Once registered, you can search the database for the funds that are most appropriate to your organisation or need and will then be able to view and print any of the results. O4C is updated every month and offers all the information required to identify appropriate funding.

# HLF WELCOMES UK APPLICATIONS FOR FIRST WORLD WAR HERITAGE PROJECTS

The 'First World War Fund: Then and Now' aims to mark the heritage of the First World War by supporting community projects in the UK which explore, conserve and share the heritage of the First World War.

Not-for-profit organisations in the UK with a bank account and a constitution can apply for grants of between £3,000 and £10,000. This includes a wide range of organisations, such as charities, trusts, clubs, interest groups, faith groups, history groups, community and voluntary groups, social enterprises, youth groups, schools and colleges.

The projects should enable communities to understand more about the heritage of the First World War and benefit a wide range of people.

To be eligible, projects should have not started yet, last for no more than two years, and achieve one or more of the following outcomes:

- Outcomes for people people will have learnt about heritage; developed skills; changed their attitudes and/or behaviour; and volunteered time
- Outcomes for heritage heritage will be in better condition;
   better interpreted and explained; identified and recorded
- Outcomes for communities more people and a wider range of people will have engaged with heritage

HLF is particularly keen that people will have learnt about heritage.

This programme has a short application form which is suitable for everyone, including first-time applicants.

There are no deadlines. Applications may be submitted at any time until 2019.

### **COMMUNITY SHARES SCOTLAND**

Crowdfunding offers both commercial and non-commercial ventures the opportunity to raise a sum of money by offering shares to people who put forward small amounts of money. Community Shares Scotland connects not-for-profit groups and investors looking to provide money for social good. People buying shares in the projects promoted through the site will recoup their investment through improvements to their community rather than profit. Social businesses can offer interest to be paid on the shares if the profit from trading is sufficient.

Community Shares Scotland hopes it can provide organisations such as community groups looking to save a local shop or start a local food scheme with access to funds.

The programme is scheduled to run for three years and its partners include the Plunkett Foundation, Co-ops UK and Rocket Science. It is funded by the Big Lottery Fund and Carnegie UK Trust through an award of £800,000.

A series of Community Shares Scotland road shows will take place across Scotland providing local groups with more information about how to get involved. Although dates have not been released yet, information will be available from their website when they are.

# ASDA COMMUNITY CAPITAL SCHEME WELCOMES APPLICATIONS

The ASDA Community Capital Scheme, administered by Social Investment Scotland, provides flexible loans of between £10,000 and £50,000 for the purpose of supporting early stage Social Enterprises with growing their business. The loans can be used for the purposes of innovation, asset purchases/improvements and for growing the organisation.

Social enterprises that are based in Scotland can apply as long as they are:

- New enterprises that have been running for less than two years
- Practicing social investment for the very first time
- Wish to take a step change in the delivery of significant social impact
- Able to show that their enterprise would benefit significantly from this loan investment in terms of financial sustainability

The terms of the loan are as follows:

- No penalty for partial or full early repayment

- · There is no arrangement fee

The Edge Fund is a very small fund that was initiated in early 2012 by a small group of philanthropists and activists who wanted to explore how funds could be distributed in a way that both devolves the power of donors and creates real and systemic social change.

The Fund supports those taking action for a just, equitable and sustainable world. Work should challenge abuses of power and aim to bring an end to the systems that cause injustice. Nor-for-profit communities, campaign groups and activists in the UK that are working for social, economic and environmental justice are eligible to apply for grants of up to £3,000. Grants of up to £1,000 are also available to individuals who face challenges because of their personal circumstances or background and have a real passion for justice and can demonstrate a clear commitment to taking action.

# SCOTTISH EMPLOYERS ENCOURAGED TO APPLY FOR EMPLOYER RECRUITMENT INCENTIVE (ERI)

Scotland's Employer Recruitment Incentive (ERI) has now resumed after a brief period of inaction. It is administered by Skills Development Scotland and is managed and delivered and managed by local authorities. Employers in Scotland may use this programme as an incentive to help young people, who may be facing significant challenges, into work. These young people should be between the ages of 16 and 29. This scheme is open to small and medium sized enterprises that are based in Scotland, from any sector. However, public sector employers are not eligible to apply.

Since the programme has been reopened, there is a now a sharper focus on the career prospects of young people who are facing the most difficult barriers in terms of employment, for numerous reasons. These young people may have a disability or may be an ex offender looking to reform their life. They may be leaving care or indeed they may even be a carer themselves.

Employer Recruitment Incentive (ERI) payments of up to £4,000 will be made available to employers who recruit a targeted young person (TYP) as a Modern Apprentice (MA) or into employment of 15 hours or more per week. This should be a sustainable opportunity complete with a contract of employment.

This payment should contribute to the costs of recruiting and sustaining a previously unemployed young person during their first 52 weeks of employment. An additional £500 is available to those employers who are committed to paying a Living Wage.

This programme has reopened and will run up until 31 January 2017.

They should explain their professional relationship with the individual or group, and describe accurately the project or activity for which money is required.

Applications from individuals or groups seeking support for themselves will not be accepted.

The Trust welcomes applications in support of the Arts, in particular the dramatic and operatic arts, music, speech and dance.

Grants may be awarded to enable individuals or groups of exceptional ability to:

- Receive special tuition or coaching, e.g. in the case of musicians, to attend Master Classes
- Participate in external competitions

### **CASHBACK FOR COMMUNITIES SMALL GRANTS SCHEME**

This scheme makes grants available to support local volunteer-led groups or units in Scotland to enhance their programmes for young people aged 10 to 19 years.

The CashBack for Communities Fund is a Scottish Government initiative that uses the money and goods seized from serious

organised criminals to make a difference to the lives of young people in Scotland.

It is being managed by a partnership of six national, volunteer-led youth organisations; The Scout Association, Girlguiding Scotland, Boys Brigade, The Girls' Brigade in Scotland, Clubs for Young People (Scotland) and Youth Scotland, the network of youth clubs and groups in Scotland.

The aim of the scheme is to support to local volunteer led groups or units, who may not previously have had access to external funding, to enhance their programmes for young people and get positive projects off the ground.

The scheme will fund the following:

- The start-up costs of a unit or youth group (up to a maximum of £1,000), particularly in areas of deprivation or need
- The costs (or part of the costs) of a particular project or programme of activity (up to a maximum of £2,000)

Eligible local units or youth groups will:

- Be led by volunteers
- Have members which include young people aged 10 or over
- Be based in Scotland
- Be a member of one of the six partnership organisations

The last requirement is to ensure all groups awarded a small grant have the appropriate national organisational support, with clear operating policies in place, and are properly constituted.

Priority will be given to:

- Start-up grant applications
- Youth groups applying for the first time

It is unlikely (except in exceptional circumstances) that a grant will be made for travel outwith the UK.

Grants are available to support the following:

- Start-up costs of a unit or youth group (up to £1,000), particularly in areas of deprivation or need
- Existing local groups to meet the costs (or part of the costs) of a particular project or programme of activity (up to £2,000) which can include the purchase of equipment

Each group or project should apply directly to the organisation of which they are a member. Applicants will be informed whether or not their application has been successful within 21 days of the closing date.

### **YOUNG START FUND**

This scheme makes grants available to not-for-profit organisations for projects that provide Scottish children and young people, aged 8 to 24 years, with opportunities to become more confident, healthy, connected and enterprising.

The Young Start Programme is provided and administered by the Big Lottery Fund with money from dormant bank and building society accounts.

Grants are available between £10,000 and £50,000 for up to two years, with the aim of creating opportunities for children and young people aged between 8 and 24 years to help them realise their potential.

Funding is available up to 100% of project costs. If only part funding is required then the total cost of the project should be no more than £100,000.

Not-for-profit organisations that are working in Scotland are eligible to apply. Examples of eligible organisations are:

- · Voluntary organisations
- Community groups
- Social enterprises
- Housing associations
- · Sports organisations
- Cooperatives
- Charities

Organisations must have:

- A written governing document such as a constitution
- At least three unrelated people on their governing body or management committee
- Recently approved annual accounts, signed and dated by a chair, secretary or treasurer, and by an auditor or independent examiner where appropriate. New organisations will require a spending estimate for the first year of the grant
- A UK-based bank account in the name of the organisation.
   This account must require two people who do not live at the same address and are not related to sign cheques or make a withdrawal

Successful applicants must complete an end of grant report to confirm what the grant was spent on and what was achieved.

From April 2016, applications from groups that have received two or more Young Start grants will not be accepted until at least two years after the most recent grant has ended.

Applications cannot be accepted from:

- Schools
- Statutory bodies
- Individuals
- Sole traders
- Profit-making organisations
- Non-departmental public bodies and government departments

Support is available for projects across Scotland that are working with children and young people between 8 and 24 years old that meet one or more of the following 4 programme outcomes:

- Confident: children and young people have more confidence and skills. Examples of the types of project that could be funded include:
  - Using local artists in a creative arts project to improve young people's confidence
  - Peer support project providing buddies and mentors for children and young people
- Healthy: children and young people have better physical, mental and emotional health. Examples of the types of project that could be funded include:
  - Youth workers providing support to young people with mental health issues
  - Getting young people involved in sport through the use of local sports facilities
- Connected: Younger and older generations are better connected and have more understanding and respect for each other.
   Examples of the types of project that could be funded include:
  - Older people teaching young people about the history of their area or skills such as cooking and gardening
  - Young people teaching older people how to use technology and try new activities such as using the internet, social networking and gaming
- 4. Enterprising: young people are better prepared for getting a job or starting a business. Examples of the types of project that could be funded include:
  - Work experience tasters with local employers
  - Volunteering placements with local social enterprises

Young Start can help by funding projects that aim to build on existing resources as well as fill the gaps or address issues in local communities to help young people overcome barriers and realise their ambition and potential. Grants can be used for the following:

All projects must meet these four mandatory outcomes:

- Outcome 1: Young people build their capacity and confidence
- Outcome 2: Young people develop their personal and/ or physical skills
- Outcome 3: Young people's behaviours and aspirations change positively
- Outcome 4: Young people's wellbeing improves

Eligible projects must also meet at least two of these further outcomes:

- Outcome 5: Schools attendance and attainment increases
- Outcome 6: Young people participate in activity which improves their learning, employability and employment options (positive destinations)
- Outcome 7: Young people participate in positive activity
- Outcome 8: Young people are diverted from criminal behaviour or involvement with the criminal justice system
- Outcome 9: Young people contribute positively to their communities

Every home in Britain will be offered a smart meter by 2020 at no additional cost, and Smart Energy GB is responsible for helping everyone in Great Britain understand smart meters, the national rollout and how to use the new meters to get their gas and electricity under control.

Local not-for-profit community groups that have a charitable purpose (e.g. charities, clubs, social enterprises, residents associations, parish councils) working with Smart Energy GB's priority groups can apply.

The funding is intended to support the costs of activities that deliver results against one or more of the following outcomes:

- Raising awareness of smart meters and understanding their key benefits
- Increasing interest in getting a smart meter installed
- Motivating people to use their smart meter
- Educating people on how to get the most benefit from using their smart meter

The following are priority groups for 2016 (this may change in 2017):

- District heating customers (district heating is a system where a communal source of heat is shared with other properties)
- Lack of proficiency in English
- · Lacking basic digital skills
- Learning disability
- Low literacy
- Memory impairment
- No personal internet access
- · Off-gas grid customers
- Prepay customers
- Private tenants
- Severe or profound deafness
- Social housing tenants

The funding, which must be used by 31 December 2016, can be used for the full costs needed to run the project, for example a proportion of staff salaries, room hire, equipment hire, transport costs, publicity materials, volunteer expenses, costs to support the grant monitoring requirements and other appropriate overheads.

Two levels of funding will be available:

- Small grants of up to £10,000 are aimed at community organisations who will work directly with one or more of the priority groups on projects to be completed in 2016
- Large grants of between £10,000 and £25,000 are aimed at regional organisations that will help reach priority groups

The 2016 deadlines for receipt of applications are as follows:

- Small Grant applications will be accepted from 17 May 2016 to 30 September 2016
- Large Grant Expressions of Interest will be accepted from 6 June 2016 to 10 July 2016

# LOW CARBON SKILLS FUND 2016-2017 OPEN TO APPLICATIONS (SCOTLAND)

Applications are now welcome for the Low Carbon Skills Fund on an ongoing basis, until 31 March 2017. However, grants will be awarded on a first come first served basis and the application process may be closed at any time during the 2016-2017 financial year. Businesses and other organisations operating in the renewable energy, energy efficiency and carbon reduction sectors in Scotland are welcome to apply, as long as they are able to meet the eligible requirements. Previous recipients have included Renewable Installation Solutions Ltd who experience business growth due to this fund and so were able to employee three new engineers as a result.

In order to apply, the business in question must be employing less than 100 workers. Applicants must be able to demonstrate that their work involves increasing the energy efficiency of products or installing lower carbon products or renewable energy resources. It is not just businesses that are able to apply for this scheme. Voluntary and community non-for-profits are also welcome to submit applications.

The purpose of this scheme is to give Scottish businesses the opportunity to employee training in areas such as renewable energy, low carbon technologies, energy efficiency, waste management and reuse, and reducing carbon in supply and energy management. It is expected that this scheme will help towards industry development and will ultimately aid Scotland in becoming more environmentally sustainable. Funding is intended to assist with the costs of eligible training activities. These training activities could include the following: qualifications, master classes, National Occupancy

Standards based learning, first line supervisory management, workshops and taster sessions.

The maximum amount of funding that an organisation may apply for overall is £5,000 and Skills Development Scotland is able to fund up to 50% of employee training costs. The remainder of the funding must be found elsewhere. There is no official limit to the number of training opportunities that an organisation can apply for, however, prospective applicants should note that a maximum of £1,000 will be granted per training session. Furthermore, the employees that are participating in the training sessions should be residents of Scotland.

Prospective candidates should register and apply online. Only one application per candidate may be made per year. Training must be conducted by an external organisation and must take place only after the grant has been received. Further information can be found on the Our Skill Force website

# Faith Organisations

### SCOTLAND'S CHURCHES TRUST

This scheme provides support to assist congregations of any denomination in Scotland in the preservation and upkeep of church buildings which are in regular use for public worship. Funding is also available for conservation work on items of special artistic quality or having associations with the history of the building and its significance to the community.

Funding is provided by Scotland's Churches Trust following the merger of Scotland's Churches Scheme and the Scottish Churches Architectural Heritage Trust.

Funding is typically for between £500 and £5,000 with the aim of assisting congregations of any denomination in Scotland in the preservation and upkeep of church buildings which are in regular use for public worship, principally by raising funds for their repair and restoration and by acting as a source of technical advice and assistance on maintenance and repair.

Applicants are required to provide the remainder of any costs from alternative sources.

Applicants may also find it useful to look at the examples of grants awarded in previous years to determine whether their project may be suitable.

Grants are not given for the following:

- Buildings outwith Scotland
- Church buildings no longer in use for public worship

- Halls, manses, other ancillary buildings, boundary walls or gates
- Bells, bell frames or organs
- Alterations or reordering
- Electrical, plumbing, heating
- Disabled access or toilets
- · Decorating costs
- Quinquennial and other regular architectural inspections
- Work that is wholly or substantially complete

The Trust will consider applications for the following:

- Repairs to, or restoration of, the structure of church buildings in use for public worship. The building need not have a congregation, but must be furnished as a church and be used for occasional services.
- Other work essential to preserve or to recover the identity or continued function of the building as place of worship within the context of an accepted religious tradition.
- Conservation work upon items of special artistic quality or having associations with the history of the building and its significance to the community.
- 4. Summary conservation reports.

Application forms are available on request from the Trust. Applicants should give their name, the name of the church, a summary of the work required and the likely timetable.

# Miscellaneous

### **ALLEN LANE FOUNDATION**

This scheme makes grants available to small registered charities, voluntary groups and charitable organisations in the UK for work that makes a difference to people's lives as opposed to simply alleviating the symptoms or current problems and should aim to reduce isolation, stigma and discrimination.

The foundation is a grant-making trust and was set up in 1966 by the late Sir Allen Lane, founder of Penguin Books, to support general charitable causes. The Foundation has no connection with the publishing company, but five of the Trustees are members of the founder's family.

The Foundation makes grants to voluntary not-for-profit organisations in the UK for work which benefits groups of people

who are under-represented in UK society. Overall, the Foundation wishes to fund work which:

- Will make a lasting difference to people's lives rather than simply alleviating the symptoms or current problems
- Is aimed at reducing isolation, stigma and discrimination
- Encourages or enables unpopular groups to share in the life of the whole community

One-off grants of between £500 and £15,000 are available. The average grant is between £5,000 and £6,000.

Grants repeated for more than one year vary from around £500 per annum up to £5,000 per annum, for a maximum of three years.

Small registered charities, voluntary groups and charitable organisations in the UK can apply. Registered charities are eligible to apply as well as other organisations which are not charities, but which seek funding for a charitable project.

To make sure its grants have an impact, the Foundation will not fund larger organisations. If an organisation works in a relatively local area — a village, or estate or small town — to be eligible it will have an income of less than about £100,000. At the other end of the spectrum, an organisation which works across the whole of the UK will be eligible if it has an income of not more than about £250,000.

The Foundation makes grants for work all over the United Kingdom but not where the beneficiaries of the work all live in London. Organisations which have their offices in London would still be eligible provided the people who benefit from their work are not only in London.

Grants may be used for start-up, core or project costs, for example:

- Volunteers' or participants' expenses
- Venue hire
- Part-time or sessional staffing costs
- Work aimed at strengthening the organisation such as trustee or staff training

The Foundation is particularly interested in unusual, imaginative or pioneering projects which have perhaps not yet caught the public imagination.

### TRUSTHOUSE CHARITABLE FOUNDATION

This scheme makes grants available to charitable and not-for-profit organisations in the UK for small, local projects working to address community issues in areas of extreme Urban Deprivation or remote, socio-economically deprived Rural Areas.

The funding is for charities and not-for-profit organisations whose projects address the Foundation's two target areas:

- Needy Rural Areas: places with fewer than 10,000 residents
- Deprived Urban Areas: places that are considered to be in the lowest 20% on the government's Multiple Deprivation Index and have more than 10,000 residents

Funding aims to improve or introduce community projects for the residents of these areas. In particular, the foundation targets three main areas and has particular interests in each:

- Health Care and Disability
- Community Support
- Arts, Education and Heritage

The following three levels of support are available:

- **Small Grants** are designed to help smallest groups who work directly within their area of need.
  - Core, salaries and project grants of up to £5,000 for organisations with an annual income under £100,000
  - Capital grants of up to £5,000 for organisations with an annual income under £250,000
- Standard Grants are aimed at small to medium sized organisation (with incomes between £100,000 and £500,000) with decisions made quarterly.
  - Core, salaries, project and capital grants between £5,001 and £10,000 for organisations

- Large Grants are for organisations with an income of up to £5 million.
  - Capital grants of between £10,000 and £40,000 for purchase, alteration and improvement of buildings, including village halls and community centres, and for large items of capital equipment such as vehicles

Established charitable organisations (including CICs, social enterprises, not-for-profit registered companies, voluntary organisations) in the UK are eligible to apply. However applicants will need to have secured 50% of their funding from other sources.

To be eligible, applicants should be:

- Small to medium sized organisations
- Have a demonstrable track record of success working to address local problems in communities in areas of extreme urban deprivation or remote, needy rural locations

The level of the applicant's income will determine which grants programme they can apply for. Total annual income refers to the total annual income for the whole organisation as shown in the latest annual accounts.

Applicants should provide their latest annual accounts. However, if this is not possible then the latest annual accounts and bank statement will also be accepted.

Applicants should note the following terms and conditions:

- The applicant will need to demonstrate within their application form that their proposed project fits with one or both of the stated overarching themes which are rural issues and urban deprivation
- For projects concentrating on rural issues, the local postcode of the area in question must be recognised as being in the bottom 50% of the latest Indices of Multiple Deprivation
- For projects concentrating on urban deprivation, the local postcode of the area in question must be recognised as being in the bottom 20% of the latest Indices of Multiple Deprivation
- Fast Track and Small Grants are only available to organisations with an annual income of less than £500,000
- Large Grants are available to organisations with an income of less than £5 million

All grants are for one year only but are available for general running costs including salaries, core costs and overheads and capital expenditure on buildings or essential equipment.

Projects should address rural issues and urban deprivation.

Applicants must clearly show in their appeal how their project fits into one or both of these categories:

- a) Rural Isolation & Poverty
- b) Urban Deprivation

### **HOSPICES**

Trusthouse is also interested in supporting capital projects at hospices throughout the UK. Applicants will need to have secured a minimum of 50% of the total cost of the project and to identify a specific element of the project which a grant from Trusthouse would cover. Priority will be given to projects that benefit patients, rather than visitors or staff. Trusthouse does not give grants for hospice running costs.

Although Trusthouse waives the need for hospices to comply with the requirement that applicants should be based in areas of extreme urban deprivation or remote rural districts, preference will still be given to such areas, as the possibilities of local fundraising are more limited.

### **THEMED GRANTS PROGRAMME**

Trusthouse runs three-year programmes focussing on a specific issue of interest to the trustees.

The latest three year Themed Grant programme focuses on local projects providing support for mothers and babies in the first two years of life. Trusthouse's grants will concentrate on three fields of activity:

- Support and activities in pregnancy which reduce stress and mental illness in the expectant mother.
- Health, diet and exercise in pregnancy and the first two years.
- Teaching mothers the vital need for bonding with their baby in the first year of life and supporting such interaction.

Grants are available for covering overheads and salary costs are available capital projects, for one-off expenditures such as equipment and new builds are also available.

Applications can be made at any time. Decisions for small grants are made within four to six weeks and quarterly for standard and large grants.

Links to start the application process are available from the charity's website undernoted

Applicants will first be taken through a short questionnaire to identify which type of grant is most suitable. The application form should be returned by post together with the additional information listed in the application form.

Successful applicants will be paid on award of the grant (for revenue appeals) or on production of copies of invoices/architect's certificates (for capital appeals).

### **WOODWARD CHARITABLE TRUST – MAIN GRANTS**

This scheme awards grant funding to small-scale, locally-based charitable initiatives in the UK in the following areas: children and young people; minority groups including refugees, gypsies and travellers; prisoners and ex-offenders; disability; homelessness; arts outreach; and environmental projects.

The trust aims to support small-scale, locally-based charitable initiatives in the UK and offers the following types of funding:

- Small grants of between £100 and £5,000 (around 100 grants are made per year)
- Large grants of over £5,000 (around five grants are made per year)

Funding is primarily for one-off projects, but the trustees are willing to consider funding running costs, including core cost and salaries. Large grants are usually awarded to charities already known to the trustees. Before submitting an application for a large grant, applicants must contact the administrator. Applications will automatically be rejected unless they have first been discussed with the administrator.

Applications are accepted from UK registered charities with an annual turnover of less than £300,000.

The trust is particularly interested in helping smaller organisations which offer direct services.

Applicants must clearly state the following:

- Who the target users are, what the projected outcomes of the work are and how many people will benefit from the grant
- If this is a continuation of existing work, what the outcomes to date are
- If the request is for a one-off project, what its legacy will be

Trustees are interested in helping smaller organisations that offer direct services and those that encourage cross community participation. Any participation by past or current users of the service should be mentioned and is encouraged.

Applications must be in support of the following activities within the trust's current funding priorities:

- Children and young people who are isolated, at risk of exclusion or involved in anti-social behaviour
- Minority groups including refugees, gypsies and travellers.
   Projects that promote integration and community cohesion will be favoured
- Prisoners and ex-offenders. Projects that help the rehabilitation and resettlement of prisoners and/or ex-offenders are supported as well as requests to help prisoners' families

- Disability projects which can include rehabilitation and training for people who are either physically disabled or have a learning disability, as well as help to improve employment prospects
- Homelessness, especially affecting young people and women, and covering facilities such as women's refuges
- Arts outreach work by local groups for the benefit of disadvantaged people
- Environmental projects, especially with a strong educational element

Application forms are available from the trust's website and all completed applications must be supported by a detailed project budget. Applicants are asked not to send their annual report and accounts, unless these are unavailable on the Charity Commission website.

Applications for large grants will be rejected unless applications are discussed with the Trust's administrator prior to submission.

The deadline for receipt of applications is 31 July 2016.

### **SOCIAL ENTERPRISES**

Social Investment Scotland All Purpose Loan Fund

This scheme provides loan support to not-for-profit social economy organisations throughout Scotland that are unable to raise funding, either in total or in part, from normal commercial sources such as banks; have a clear social purpose that will make a real difference to the communities in which they operate; and can demonstrate long-lasting social impacts.

Social Investment Scotland (SIS) is a unique partnership between Scotland's four biggest banks and the voluntary and public sectors. SIS provides loan finance and business support to social economy organisations that are unable to raise any or all of the loan finance they need from normal commercial sources.

### 1. Social Investment Scotland/Triodos Property Loan:

Loans for a wide range of purposes such as: the purchase of new or existing premises; the development or upgrading of premises or even the construction of completely new premises.

Key features:

- Loans from £30,000
- Competitive interest rates
- Quick decision
- · No penalty for partial or full repayments
- Option for SIS to arrange either part or the entire total borrowing requirement

Note: for property purchase, it is possible to borrow up to 95%, and in some cases 100%, of the value of the property due to a new arrangement between itself and Triodos Bank.

### 2. Social Investment Scotland Bridging Loan:

Loans are available for applicants, who need money at short notice, for relatively short periods enabling their project to go ahead, and for invoices to be paid while they claim grant money.

### **Key Features:**

- Loans from £10.000
- Competitive Fixed interest rate at 7% and fees 2%
- Fees waived if subsequent borrowing taken
- Security not required
- Quick decision

SIS will seek to take security for the loan where appropriate, which may involve securing property the applicant already owns or a property they are purchasing with the loan. It does not, however, seek a personal guarantee. Taking a security over property acts as a safeguard for SIS as it means that, should the applicant fail to make repayments under the loan, it has the right to take on and sell the property.SIS will normally lend amounts starting from £10,000 up to £250,000.

Social Investment Scotland seeks to encourage enquiries from social economy not-for-profit organisations, including social enterprises, community and voluntary groups, and the trading operations of charitable bodies, community businesses, cooperatives, Community Development Finance Initiatives (CDFIs) and housing associations. Applicants should have the following characteristics:

- Be non-profit distributing
- Be unable to access the finance needed from commercial sources such as banks
- Have a clear social purpose that benefits disadvantaged vulnerable groups
- Be able to make a long-lasting social impact with the loan
- Be based in Scotland and serve the Scottish market
- Have borrowing powers within its constitutional documents
- Be allowed to borrow under the organisation's constitution

Full details on SIS's terms and conditions and how to apply for loan support, can be accessed from their website.

Note: SIS does not compete for business with High Street banks. It tends to lend where there is a higher degree of risk and some potential borrowers have not had their needs met fully by such banks. A key benefit is that because SIS only provides fixed rate

loans, it means that rates will not rise during the term of the loan hence providing certainty during the borrowing period.

Organisations wishing to apply for a loan should first submit the preapplication form available online. All full applications should include the following:

- A Business Plan incorporating financial projections for the next three years
- The last three years audited accounts (less if the organisation has not been in existence for three years)
- The organisation's constitutional documents which usually take the form of a Constitution or Memorandum and Articles of Association
- Income and expenditure forecasts for the current financial year

### Women

### **FEMINIST REVIEW TRUST**

This scheme makes grants available for projects in the UK and internationally that transform the lives of women.

Individuals and organisations in the UK and internationally are eligible to apply for grants of up to £15,000. However, the trustees rarely give out awards of this amount; applicants should also bear in mind that they may only be offered partial funding.

Please note that successful applicants will be required to display the trust's logo on all material associated with the project and provide a final report.

Funding is for projects that relate to the trust's objectives, which are:

- To advance the education of the public in the subject of gender
- To promote equality of opportunity between women and men in any part of the world
- To alleviate poverty and hardship by promoting and advancing good health and education among women in any part of the world
- To undertake other charitable purposes

### THE TRUST WILL FUND THE FOLLOWING:

- Hard to fund projects. Some types of projects are difficult to fund. Typically these projects have no other obvious sources of funding. This might mean, for example, that traditional academic sources are either not interested in the area or that it is an activist project or that it is too feminist for most conventional funding sources. For example the trust supported the writing and publication of the history of Rape Crisis in Scotland and the translation and updating sections of 'Women and Their Bodies' into Arabic and Hebrew.
- Pump priming activities. This means that the trust will provide
  a small amount of funding to help start an activity in the hope
  that it will then be able attract sufficient funding to continue.
  For example the Trust funded a project in Argentina to
  strengthen the capacity of organisations promoting women's
  rights and a project to provide audio visual equipment for a
  feminist social centre in Madrid. In each case these projects have
  hopefully helped to create a sustainable activity.
- Interventionist projects which support feminist values. It is often difficult for projects around core feminist concerns such as abortion rights and domestic violence to find funding. The trust has supported, for example, Asylum Aid (an independent charity workshop with asylum seekers in the UK) to promote its 'Charter of Rights' for Women Seeking Asylum. The Trust has also supported the 40th Anniversary Campaign of Abortion Rights in the UK, a documentary about abortion in Trinidad and Tobago and a feminist art studio in Tbilisi, Georgia.
- Training and development projects: funding for projects which
  provide training in relevant areas. For example, the trust has
  funded English lessons for sex workers in London; leadership
  skills training for women in the voluntary sector and volunteer
  training at Glasgow Women's Library.
- One off events: the trust supported Cine25 as part of the
  celebrations of 25 years of Women's Studies at the University
  of York (UK); a seminar for the Lileth Project (a violence against
  women housing related project), and a workshop on the gender
  dimensions of Bulgarian Immigration Policy.
- **Dissemination**: the trust will fund the production and distribution of relevant material. Too often work has had a more limited impact than it should because it was not well distributed. For example the trust has supported the production of a booklet on Asian women's experiences of higher education in the UK and the distribution of publications by the Rights of Women (a non-profit UK group).
- **Core funding**: the trust realises that many groups struggle to raise core funding. The trustees are willing to offer core funding to cover staff costs, accommodation etc.

 Other projects: the trust may still support an application that does not easily fit into any of the above categories.
 For example, the trust has funded a project to capture oral histories of women's experience of the menopause. Applicants should contact the trust to discuss eligibility prior to submitting an application.

Application forms are available to download from the trust's website and should be returned by email. Where projects include a research element, applicants should describe the steps that have been taken to ensure the research will be undertaken in an ethical manner and careful attention should be paid to the costs.

Not for profit groups in Scotland are eligible to apply for two levels of award:

- Small Grants of between £500 and £2,000. Grants must be spent within one year and the total project cost must not exceed £8,000
- Large Grants of up to £30,000 (£10,000 maximum for each of three years)

The 2016/17 deadlines for applications are 28 June 2016 (4pm), 28 September 2016 (4pm) and 6 January 2017 (4pm).

Any applications received after the deadline will automatically be entered for the next round.

This scheme, operated by Innovate UK (IUK), provides funding for businesswomen who have the potential to be successful entrepreneurs and leaders in innovation. A package of tailored support will assist those who have the ideas and flair to deliver significant economic growth through their operations.

The support on offer includes:

- Training on pitching to investors
- Introduction to investors
- Media and communications training
- Intellectual property advice provided by the Intellectual Property Office
- Training in developing new business models
- Access to the RAEng Enterprise Hub

It also includes guidance and advice on:

- · Accessing funding programmes;
- Evaluating market opportunities; and
- Making introductions to contacts in their sector through the Knowledge Transfer Network/European Enterprise Network and Catapults.

In addition to this, the four overall winners (IUK expects to have a winner in each of the Innovate UK sector areas) will receive £50,000 to support their innovation project/activities.

- Large Grants of up to £30,000 (£10,000 maximum for each of three years)

Not for profit groups in Scotland are eligible to apply but must:

- Be constituted
- Have at least three members on the management committee/board
- Have independently examined annual accounts or a projection of income and expenditure if in the first year of operation
- Have an income of less than £250,000 in the organisation's most recent annual accounts –

# LLOYDS TSB FOUNDATION FOR SCOTLAND — HENRY DUNCAN AWARDS

Lloyds TSB Foundation for Scotland owes its existence to The Reverend Henry Duncan, who founded the Trustee Savings Bank in Ruthwell, Dumfriesshire in 1810. He started the Bank so that everyone, regardless of wealth or position, could benefit from a savings bank.

Grassroots charities operating in Scotland are eligible to apply for grants of between a few hundred pounds and £7,000. Organisations must have an income of less than £500,000 per annum and able to demonstrate that at least one of the following will be achieved:

- Improve family welfare
- Reduce isolation
- Improve health and wellbeing
- Increase independence or life skills
- Improve community cohesion and integration

The services/projects supported through the awards will typically address one or more of the following issues:

- Challenging family circumstances
- Mental health
- Community segregation and territorialism
- Disability
- Physical, emotional and sexual abuse
- Drug and alcohol issues
- Isolation of older people
- Homelessness
- Illness and poor health
- · Lack of equality
- Poverty
- Lack of development opportunities for disadvantaged young people

Please note that priority will be given to applications that are focussed on supporting:

- Vulnerable children and young people
- Isolated older people

- People debilitated as a result of a disability or mental health issue
- Families in poverty, particularly as a result of welfare reform
- Carers

Funding can be for salaries, core costs and running costs.

Consideration will also be given to applications for small capital projects such as equipment.

Successful applications will clearly demonstrate the difference this support makes and how quality of life will be improved in the longer term.

Funding is unlikely to be given to charities which hold more than 12 months unrestricted reserves; and where an award is made, reapplication is not possible until at least 12 months have elapsed from the date that the original grant was awarded. Unsuccessful applicants are not eligible to reapply to this programme for 12 months.

Successful applicants must submit a progress report 12 months after the date of release of funding.

# DEADLINE APPROACHING FOR THE ANCIENT MONUMENT GRANTS SCHEME 2016

Ancient Monument Grants are provided by Historic Scotland. The purpose of these grants is to support monument owners and land managers who are undertaking conservation, management and maintenance works in relation to a historic monument. Other bodies who are acting with the owner's written approval will also be considered. The monument in question will need to be in proven need of conservation or else should have significant historic interest. Priority is given to monuments that are of particular interest or notability.

Grant support can cover a percentage of eligible costs, including consultancy and scheduling, and will help to preserve and maintain ancient monuments throughout Scotland. There is no official fixed rate of grant. However, the programme has a limited budget and so the maximum annual grant for a project will very rarely exceed £50,000. In making a decision, the judging panel will take into consideration the urgency of the repair work needed as well as whether or not the applicant has access to other possible sources of funding.

Eligible work is generally related to the conservation of existing fabric and associated below ground archaeological work. Eligible expenditure may include the acquisition or removal of a monument for the purpose of preserving it or the provision by a local authority of facilities, information or other relevant services at a monument which is open to the public. It is expected that recipients of this grant will ensure that their monument is accessible and can be enjoyed by the general public.

The next deadline for this scheme will be 31 July 2016.
